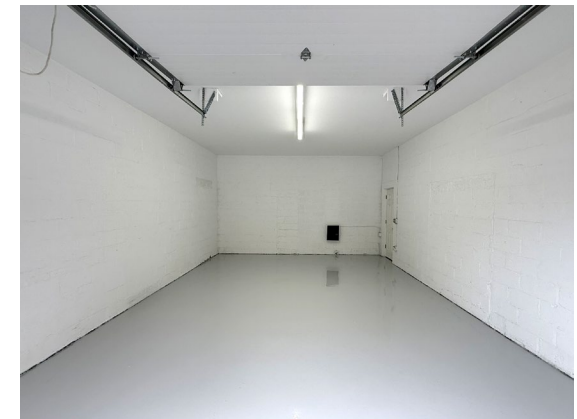
The property is conveniently located less than 1/2 mile from Route 46 and ±5 miles from Route 80.

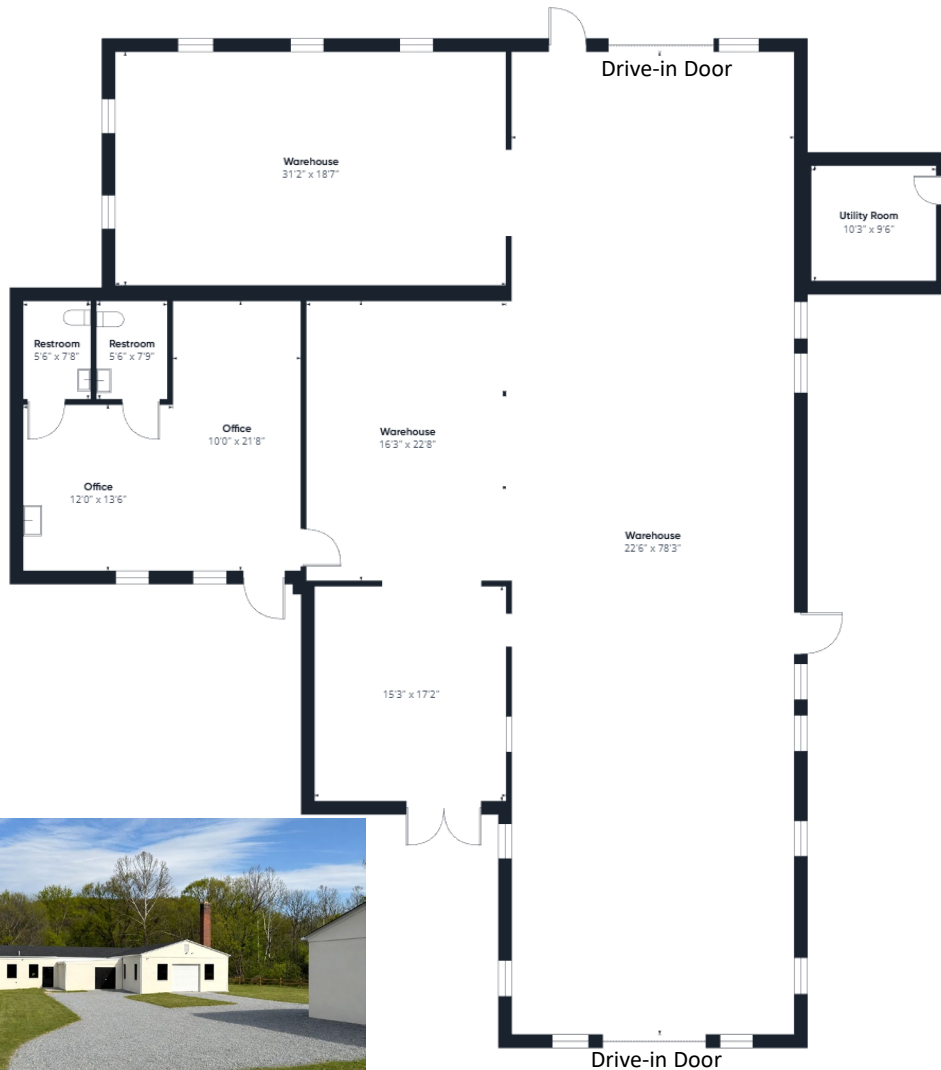

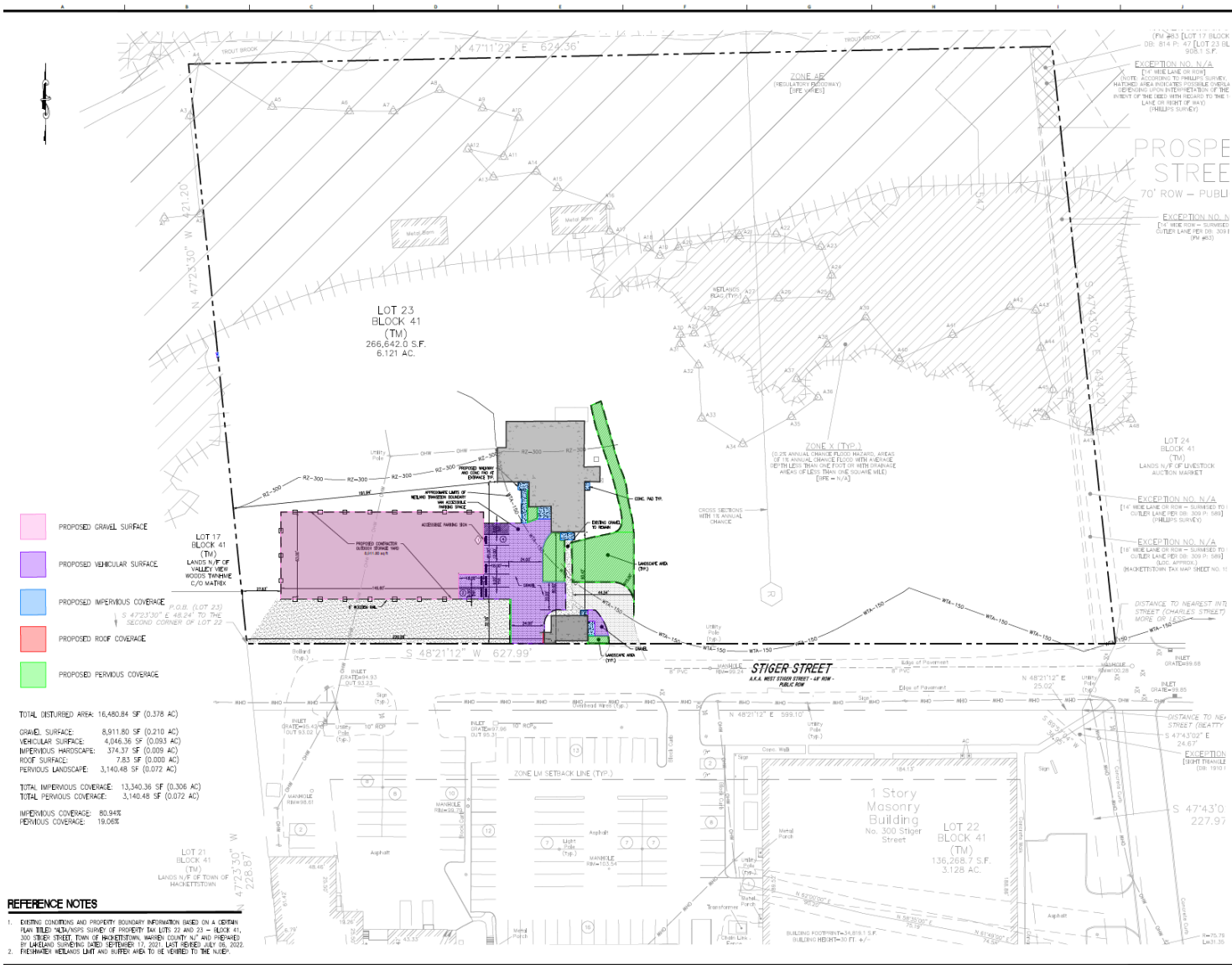

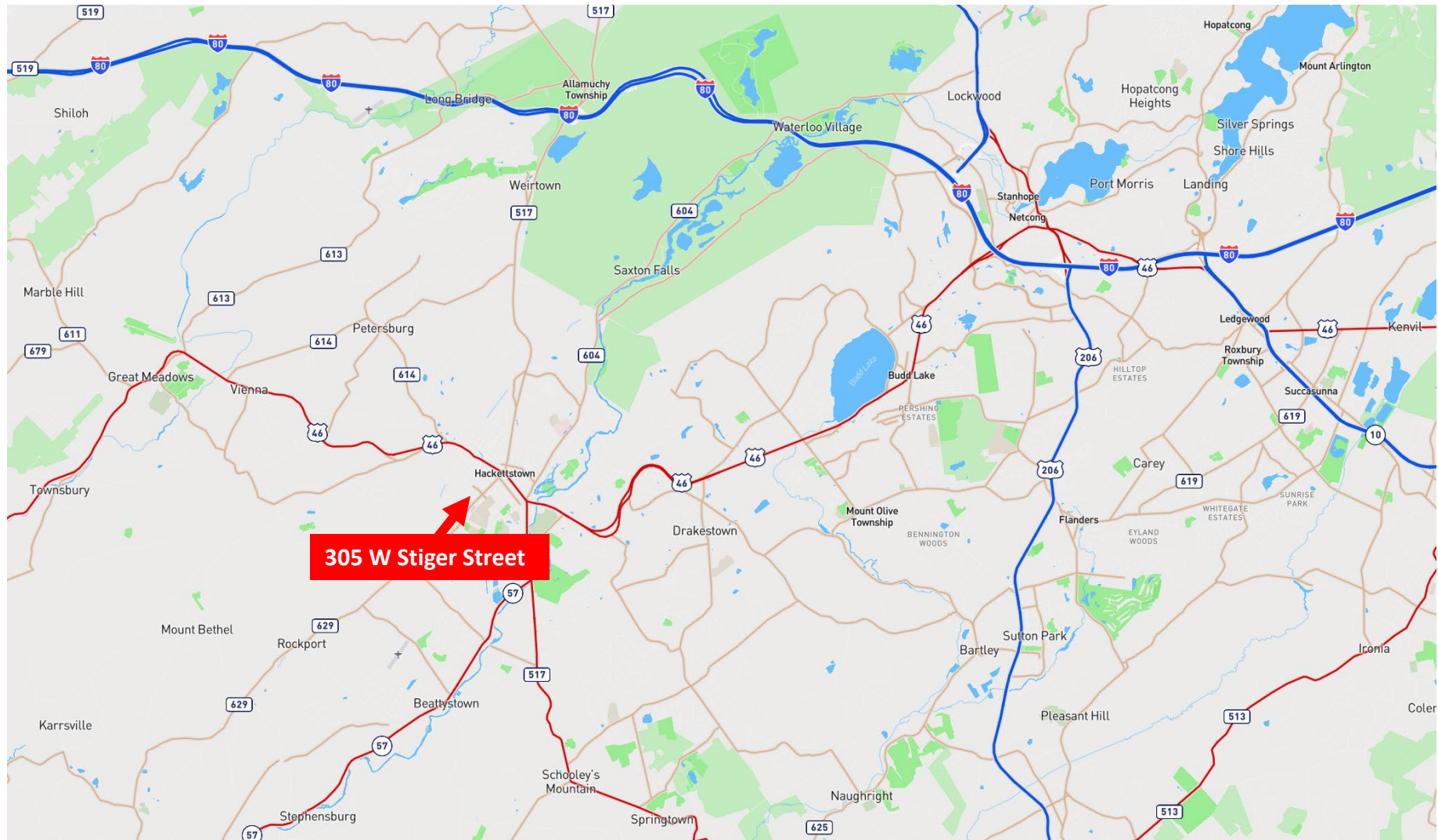
